Integrity Comeback

Sam White linked insights for NIAA in the Robodebt Royal Commission, current integrity developments across the APS and gave an update on the National Anti-Corruption Commission (NACC). He identified that 'we', the SES, set the standard and we model the behaviour and gave an appropriate reminder not to forget you and your staff can reach out.

Vance, Simon and Shane shared their groups insights on their integrity implementation plans developed from the last SES recall, linking back to Jody's opening address about the need for SES to be seen working together. Key highlights in this session included:

- the need for clearer pathways;
- record keeping (e.g. use of CRM);

- building a psychological safe environments;
- group and branch integrity sessions for staff critical;
- fair and transparent recruitment;
- performance management; and
- the need to triangulate information.

The Cohort acknowleged that this could be achieved by having clear escalation points to enable NIAA (the CEO) to make a judgement about serious or systemic integrity issues, which are then escalated to the Commissioner with the Commissioner making the final decision.



- The Royal Commission made 57 recommendations.
- Some themes from the recommendations relevant to NIAA's business include:
 - Consultation with peak bodies
 - Consultation and feedback from frontline staff
 - Failures in the Budget process (provision of legal advice in developing New Policy Proposals)
 - Lawyers in the APS and provision of in-house legal services
 - Documenting decisions and discussions (APS improvement recommendations)
